

# Chol Majok's Mayoral Policy for Better Code Enforcement & Quality of Life

Building a Cleaner, Safer, and More Livable Syracuse

#### Introduction

A clean, safe, and well-maintained city is essential for fostering strong communities, attracting businesses, and improving overall quality of life. However, Syracuse struggles with inefficient code enforcement, neglected properties, and outdated permitting processes that hinder progress. As mayor, I will modernize our code enforcement department, streamline permitting, strengthen community engagement, and leverage advanced technology to ensure Syracuse is a clean, well-managed, and inviting city for all residents.

### I. Modernizing the Code Enforcement & Permitting Process

Efficient and transparent code enforcement benefits everyone. My administration will implement digital solutions and proactive strategies to create a seamless process for residents and businesses.

## **Key Initiatives:**

- Online Application & Live Tracking
  - o Develop a real-time application tracking system for permits, inspections, and code violations, eliminating unnecessary office visits and phone calls.
  - Ensure full transparency by allowing applicants to check the status of their requests online, reducing delays and frustration.
- Automated Notifications & Digital Communication
  - o Introduce text message and email alerts to notify residents and businesses of code violations, permit approvals, and application updates.
  - o Shift focus from punitive fines to proactive compliance, ensuring residents have ample opportunity to address issues before penalties apply.
- Transparent Fee Structure
  - Publish all licensing, permit fees, and code violation fines publicly on the city's website for easy access and transparency.

### II. Enhancing Customer Service & Permit Approvals

An effective code enforcement department must be well-staffed, responsive, and resident-focused. My administration will ensure a streamlined system that supports businesses, property owners, and residents.

#### **Key Initiatives:**

- Reducing Permit Processing Delays

  - Establish fast-track permitting for projects that meet pre-approved criteria, reducing delays for developers and homeowners.
- Proactive Support for Residents & Businesses

  - o Train city employees to prioritize customer service excellence, ensuring residents feel supported, not burdened.

- Eliminating Unnecessary Fees & Barriers
  - o Review and eliminate redundant permit fees, reducing financial strain on homeowners, small businesses, and developers.
  - Create affordable permit options for small-scale home renovations and property improvements.

### Key Initiatives:

- Anonymous Online Reporting Portal

  - o Encourage proactive enforcement by responding swiftly to resident reports.
- Neighborhood Code Captains
  - o Recruit and train volunteer neighborhood ambassadors to monitor and report code violations such as trash accumulation, overgrown lots, and vacant properties.
  - o Facilitate monthly check-ins between neighborhood leaders and code enforcement officials to ensure ongoing communication.
- Community Clean-Up & Incentive Programs
  - o Launch block-by-block cleanup challenges, where neighborhoods receive city resources and incentives for maintaining clean, code-compliant communities.
  - o Offer property maintenance grants for elderly and low-income homeowners struggling to keep their properties up to standard.

#### IV. Leveraging Advanced Technology for Code Enforcement

## **Key Initiatives:**

- Drone Monitoring for Illegal Dumping & Property Neglect

- GIS Mapping for Targeted Enforcement

  - Standardize inspection schedules for rental and commercial properties to ensure compliance.
  - o Establish clear, publicly available guidelines on property maintenance responsibilities for homeowners, landlords, and business owners.

### Key Initiatives:
